Dear Coaches, Parents, and Goalkeepers

My name is Seong Ha, head varsity girls soccer coach at Glenbrook South High School and director of the Chicagoland Elite Goalkeeping Academy. This summer, we have formed a goalkeeping coaching staff that is the most experienced in the ten years of offering this camp. The various backgrounds of coaching expertise are unmatched in the area for youth and high school level goalkeepers. This summer's comprehensive camp are for ages U10 and up through varsity-level goalkeepers. In addition, we have had some 40-50 goalkeepers from some 20+ high schools around the area. Our goal is to provide a comfortable coach to goalkeeper ratio to meet the fundamental needs of your player, son, or daughter.

This year we are offering three types of goalkeeping disciplines (camps vary on age, not necessarily on ability):

- **Intermediate Goalkeeping** – for U10 through U12, (youth-level) focusing on an all-inclusive fundamental training.
- **Advanced Goalkeeping I** – for U13 through U15, fundamental repetition/reinforcement primarily for premium core goalkeeping skills and activities. Refining technical aspects for future development are focused on.
- **Advanced Goalkeeping II** – for U16 through U18, high intensity sessions primarily for JV / varsity goalkeepers. Goalkeepers will be taught specialized situations and quality tactical information to be used within a high level match.

The camp is at the Trevian/F.C. United (Niles, IL) INDOOR facility. The address is at 6368 West Howard Street, Niles, Illinois, 60714. The duration of the camp is four days from Monday, June 27, 2011 through Thursday, June 30, 2011. The camp starts at 1:15PM and ends at 4:15PM. Each goalkeeper will be given a sackpack bag. The tuition cost of the camp is \$165.00, if received before (not postmarked) Friday, June 24, 2011. If received after or during the camp, the tuition is \$215.00. Checks are payable to Seong Ha.

The camp is individually centered on creating a positive learning experience and environment in which to advance their goalkeeping skills. Whether tactically, psychologically, technically, or physical conditioning, each goalkeeper creates for themselves a structure in which to excel. Critical development comes from building upon successes that goalkeepers have achieved, while recognizing and tackling obstacles they have confronted, and providing solutions in that your son/daughter will strive positively, competitively, and most of all, enjoy the goalkeeping position.
